1. Task Organization:

2. 4-3 Inf occupies assigned blocking positions in Song Ve Valley in support of 4th ARVN Regt operations in ARC LIGHT area; continues offensive search and ambush operations in the SAN JUAN HILL FCA to find and destroy NVA main/local force units and village VC infrastructure.
