At 0155H LZ SAN JUAN HILL rec'd 3 incoming 82mm mort rds with neg cas or damage. At 0725H Bn CO (ITC Davis) rept'd the lift ships and gun ships for the CA took fire at BS615405. Arty was called in. At 0727H Co C completed a CA fr BS47391 to BS592397. At 0850H Co B completed a CA fr BS479387 to BS592387. Both LZ's were cold. At 0925H Co C fd 300 lbs of unpolished rice at BS589398 and destroyed it. At 1230H Co B at coord BS588388 fd 500 lbs of rice and some docu. The rice was destroyed and the docu brought to SAN JUAN HILL. There were neg other significant events throughout the day.
