At 1005 at XD922533 the 2d platoon of A Co was engaged with command detonated claymores, chicomos and small arms fire. The remainder of the company moved to assist. Arty and air strikes were employed. The results were 2 US KIA and 8 US WIA. Enemy casualties were unknown. At 1520 D Co was returned to control of 4-3 Inf. At 1830 at XD908550 C Co CP observed 10 NVA and called in Arty with unknown results.
